Performance security should remain valid for a period of 60 days beyond the date of completion of all contractual obligations of the Caterer including agreement etc. In lieu of Performance Security so received, the EMD of the successful bidder will be released/returned.
- 7. **Signing contract: within 21 (twenty-one)** days of issue of the contract letter by the purchaser, the successful bidder shall sign and date the contract and return it to the purchaser.
- 8. The Director reserves the right of accepting or rejecting all or any application for issue of tender form and subsequently of accepting or rejecting all or any part of the tender without assigning any reason. Further, the Institute reserves the right to verify the information/document furnished and to carry out assessment of capability of the Tenderers, should the circumstances so warrant in the overall interest of the Institute. In all matters of disputes, the decision of the Director of this Institute shall be final and binding on the Tenderer.
